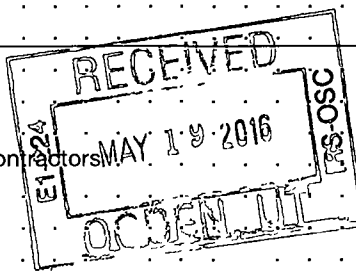

An Amendment to the Certificate of Incorporation was filed in December 2015 to clarify that in the event of dissolution any assets will be distributed to an exempt organization, or for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
